Feature video-based lessons, teacher implementation supports, at-home family reading resources, and leader guidance documents



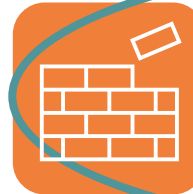
CONNECTED LITERACY

What is Reading 360[®]?

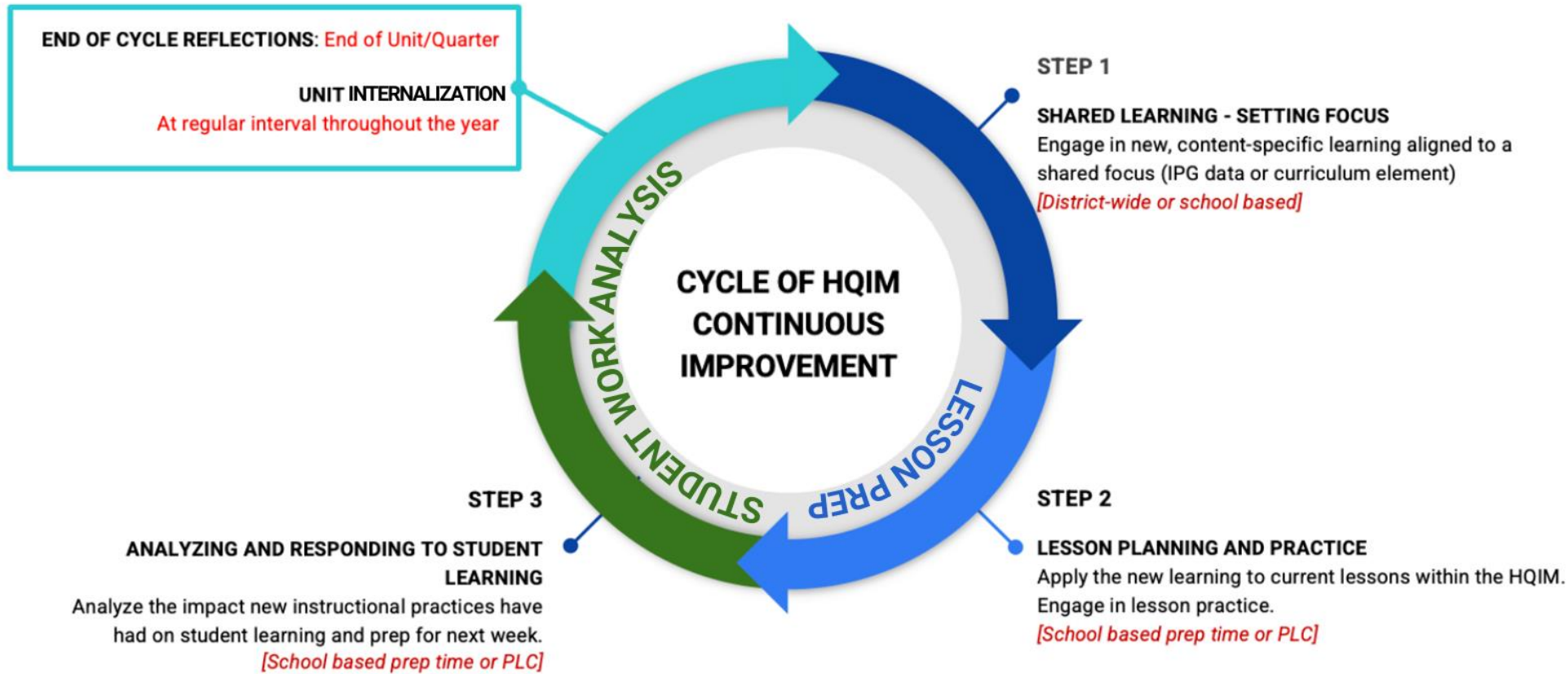


A *comprehensive* approach that includes systematic foundational literacy, educator and leader preparation, instructional materials, training, coaching, ongoing support, and online and family resources

HQIM Cycle of Continuous Improvement



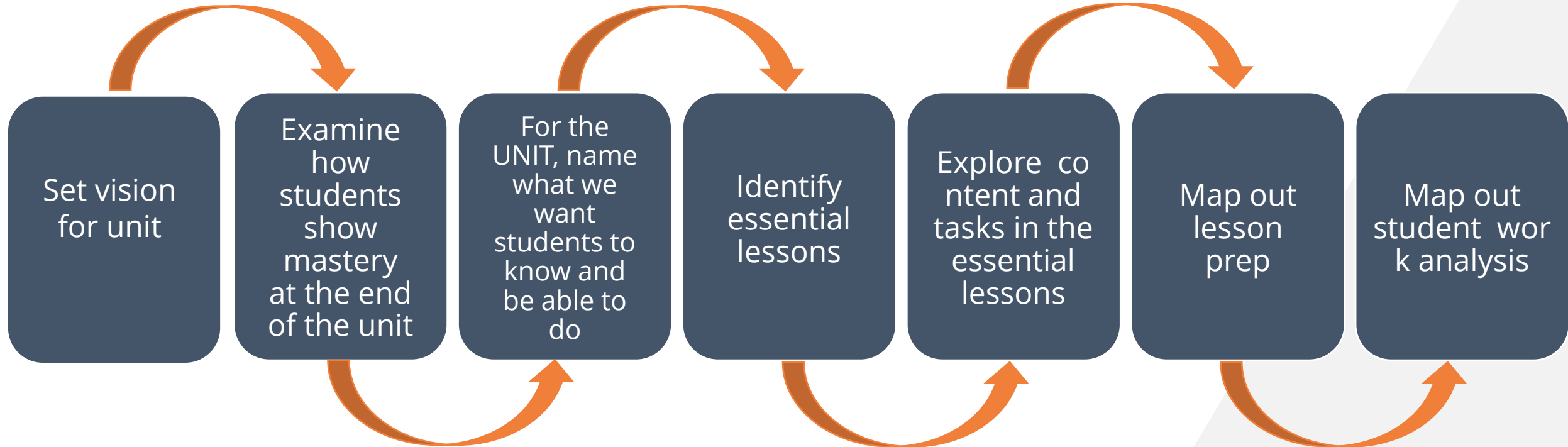
Why Unit Preparation?



Unit-level preparation enables teachers to:

- Understand the vision of the unit
- Collaboratively examine the expectations of the end of unit assessment for all students
- Internalize what mathematics all students should be able to know and do by the end of the unit and the progression of math concept and skill development.
- Determine how to support challenging and pivotal mathematics concepts through the unit
- Identify the lessons that need to be collaboratively prepped and the student work to be analyzed.

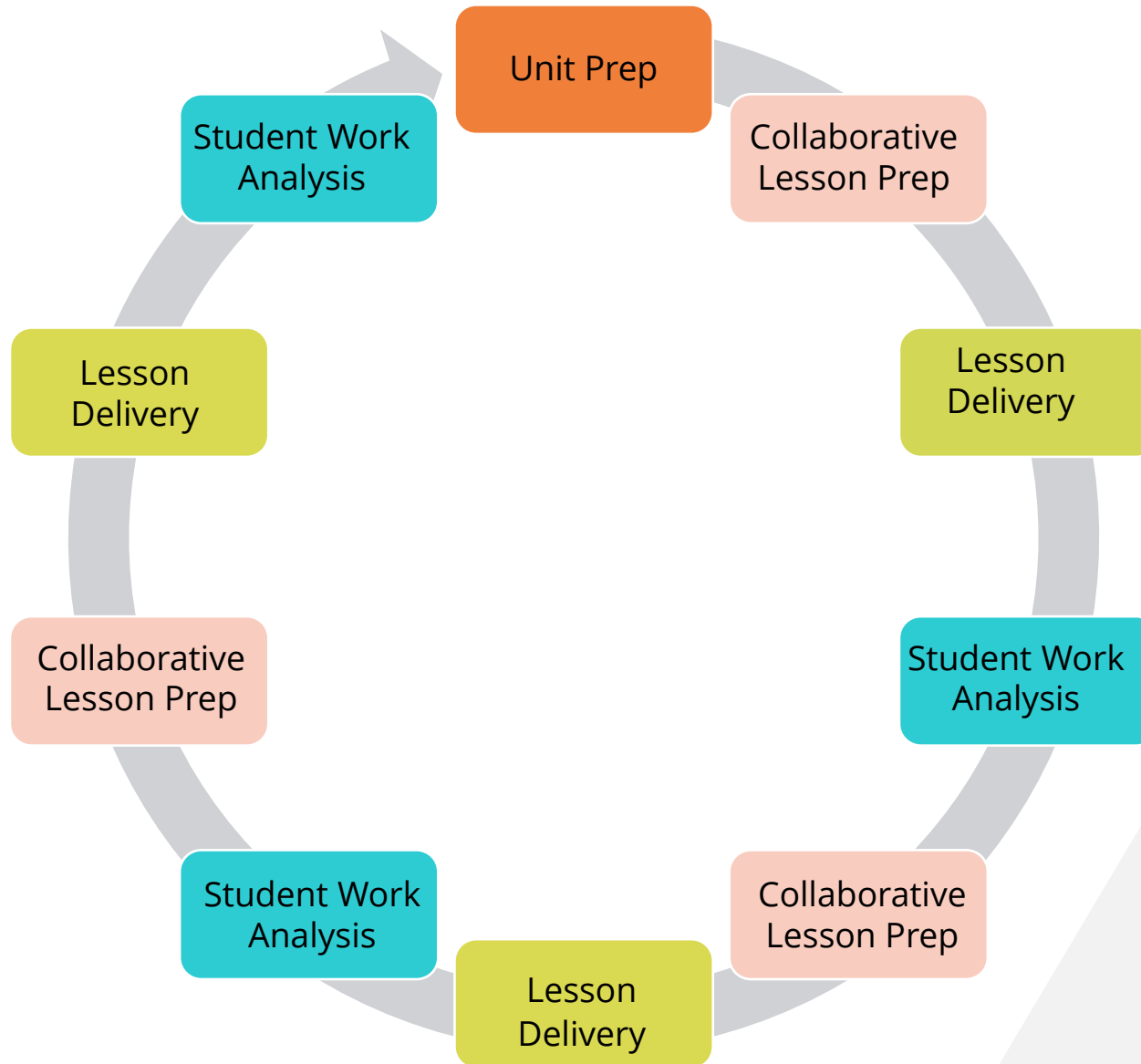
Why Lesson Preparation?



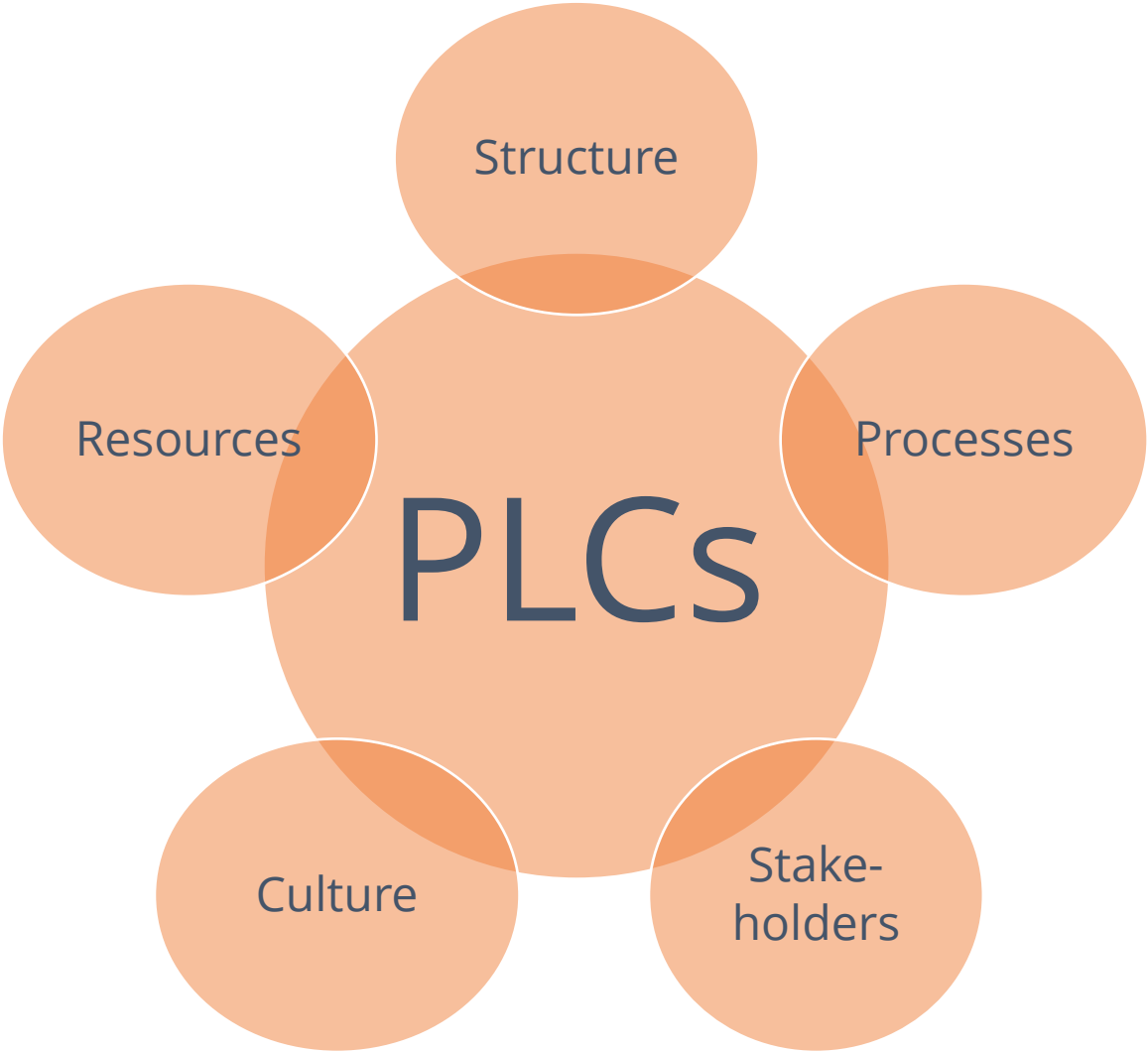
Prioritized lesson-level collaborative prep enables teachers to:

- Allows deep understanding of the lesson and its math concepts
- Share the understanding of student needs and challenges
- Co-prepare the student supports to ensure all students have equitable mastery
- Set common expectations for student mastery and student work

Engagement

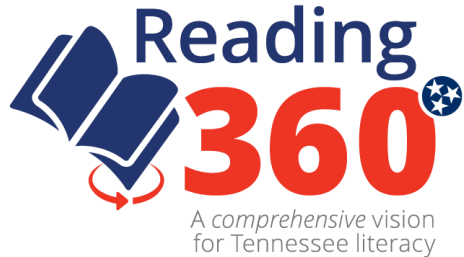
- Monthly regional learning webinars
